HOW TO ENTER

NO PURCHASE IS NECESSARY TO ENTER OR WIN. Register to win by completing and submitting the form marked “LP SmartSide “Smooth Sounds” Giveaway” along with one of two LP rebates titled a) LP SmartSide First Time Trial Offer Up to \$1,000 rebate (“First Time User Rebate”) or b) LP SmartSide Model Home Offer up to \$2,500 (“Model Home Rebate”) and together, the “Rebates”). ELIGIBILITY

PRIZES

Grand Prize winners will have seven (7) days from date of notification to claim their prize.
